Minutes - It was proposed by C Packer and seconded by M Worsnop and **RESOLVED** that the minutes of the proceedings of the Ordinary Meeting held on 25th February 2021 be confirmed as a correct record and will be signed by the Chairman when restrictions are lifted

Appointment of Auditor: John Dennis kindly agreed to audit our accounts again this year

County Councillor's report : No report in his absence

District Councillor's report: 2 Senior members of the HBC Parks Dept have retired after serving a total of 90 years between them. Tom wished them both a happy retirement and stated they would be sadly missed. The Convention Centre will be handed back to the Council from the 31st March 2021 and will be dismantled by the NHS before returning to a conference centre. A new road sign has been erected at Collin Spring Court stating 'no through road' this will hopefully stop unauthorised vehicles entering the development. The Parish Councillors' stated it was very difficult to contact anyone at the Council Offices since the Covid outbreak. Telephone calls and emails were not being answered so Tom suggested we wrote to Rachel Bowles Corporate Affairs Manager HBC explaining the situation.

Updates regarding:

Playground: Reversing hinge on gate and fixing new bench to be completed shortly. Signs will be erected once this work is done. Clerk to chase Insurance Co re our claim for the Rocker Spring. Uneven ground in playground the Chairman had spoken with Jenny Love at HBC regarding this and she gave him a list of suppliers who might be able to suggest an alternative to grass possibly putting grass matting down which would allow the grass to grow through. The Chairman will meet the Parish Caretaker to see if he would be willing to undertake this job. Now the plastic sheeting has been removed from the entrance to the playground it was suggested that the Parish Caretaker may be able to either reseed or turf the area. It was proposed by R Houseman seconded by C Packer that the Chairman be given permission to proceed with the work.

Highway matters: The footpath on Wreaks Road has been marked out for repair and the Chairman will meet shortly with the Highways Inspector re the pinch point and other areas causing concern, Elton Bank has also been marked out so hopefully work will commence shortly but regarding the Broomfield parking situation no further info to date. Sandbags filling and managing our own allocation still seems to be the best option. Clint Bank and the footpath around the corner a meeting with NYCC will take place to find out what is envisaged.

CCTVBus Shelter: The painting will commence next week and the CCTV monitors will be installed

BIB: re: entrance to playground (see Playground notes)

Nidderdale Greenway: Two possible alternative routes had been discussed there are pros and

cons for both. The alternative route has the benefit of avoiding the narrow stretch of road over and approaching the bridge. It was noted by Malcolm Margolis the amount of traffic that travels along this stretch of Wreaks Road. Mr Margolis said it was not correct to describe the Greenway as a 'cycle track'. He states its a path for walking, cycling, running, scooting and where ever practicable for horse riding. He stated the Greenway will not come to Birstwith for a considerable length of time and this would be subject to landowners support.
