COUNTY COUNCILLOR'S REPORT Boundary update Michael Harrison stated an Order will go in front of Parliament next January. A full boundary review will take place in 5 years time. No elections next year Councillors will carry on until 31 March 2023 this will allow councillors to shadow along side the District Council. There is a possibility in future of replacing District Councils with Town Councils. He reported a 100 packages of care had been covered by council staff but that there were a shortage of care home staff. In November any care worker not double vaccinated will not be allowed to work in this sector

Report from District Councillor: Tom Watson told us the NHS had paid the account for the Nightingale hospital which is good news for HBC.

Update on matters arising: Vehicle Activated Sign on Clint Bank - Is now up and running outside the Doctors Surgery

Car Park: The clerk has obtained an official copy of the title plan and a few P Councillors will meet with Glenn Levison from HBC in September and report back to the PC

Highways: Michael Harrison confirmed jetter gulley equipment will be used to clear drains in various areas of Birstwith within the next 10 days. Wreaks Road will hopefully be resurfaced shortly and the manhole cover near the pub will be reinstated by Yorkshire Water. The parish councillors reported the atrocious road surface outside Collin Spring Court and the Doctors Surgery. Also to look into the 30mph signs which have been moved on that stretch of road due to the new development – Michael is going to look into these problems for us and report back.
