COUNTY COUNCILLOR'S REPORT - No report in his absence

DISTRICT COUNCILLOR'S REPORT – Tom reported that sales at HBC nursery at Harlow Moor Road have increased and the nursery is open to the public for sale of plants etc. Check opening times on their web site. HBC Pet Cremations is due to commence from April next year and it is understood one pet cremated at a time. Housing in Nidderdale AONB there are over 200 residents in the Nidderdale AONB area on the council waiting list in need of rented homes. 5 council homes in the AONB have been lost under the right to buy scheme. Local Government Review for North Yorkshire – The proposal is to elect 90 councillors to the new Council. Draft proposals for wards in **Nidd Valley and Washburn Valley** this means that 2 new wards will be created. 1. Pateley Bridge and Nidderdale Moors which will include: Pateley Bridge Town, Upper Nidderdale Parish, Bewerley Parish, Dacre Parish, Darley with Menwith Parish, Thornthwaite and Padside Parish and Thruscross Parish. 2 Washburn Valley & Birstwith and will include Washburn Valley Ward (HBC), Hartwith cum Winsley Parish, Birstwith Parish and Felliscliffe Parish

Highway Matters: The stone column on Lackon Bank has now been repaired Sandbags a small team of volunteers has come forward to help with the filling of the sandbags. Debris under river bridge and flooding problems in Broomfield – The Chairman is working with Dave Gilbert Harrogate Borough Council Surveyor on these problems so hopefully a solution will be found in the near future. High Lane rose trees on grass verge responsibility unknown. Tang Road – Laurel bush needs cutting back the village caretaker to be asked to undertake this task.
