**To receive Parishioners questions** – Michael Bartholomew Chairman Yorkshire Dales Green Lanes Alliance attended the meeting. He gave a short summary of what YDGLA was about stating the Alliance were campaigning to free Green Lanes in the Dales from recreational motorbikes and 4 x 4s. He stated the only motors that should use green lanes are those driven by farmers and others with a legitimate need for access such as residents and their visitors and the emergency services. His email arrived to late to go on our agenda this month but will be discussed in September.

**MINUTES** - It was proposed by M Worsnop and seconded by D Fisher and it was **RESOLVED** that the minutes of the proceedings of the Meeting held in the Reading Room on 23rd June be confirmed as a correct record and signed by the Chairman

## **COUNTY COUNCILLOR'S REPORT** - No report in his absence

**DISTRICT COUNCILLOR'S REPORT** – District Cllr Tom informed the meeting that there were 180 residents in the AONB looking for housing. He stated the Council had bought back two Council houses using funds from the Housing Revenue Account and they had been rented back out within the AONB. Another 14 houses have been purchased by the Council on Whinney Lane Pannal but in 5 years these properties can be bought by the tenants for a much reduced figure. This year it is 125 years since the Harrogate Turkish Baths opened. On the 18<sup>th</sup> July Yorkshire Water recorded the highest amount of water ever used due to the extremely hot weather conditions. Reservoirs are 20% lower than expected at this time of the year.

# **Updates on the following:**

**Playground** – An inspection by Park Lane Playgrounds suggest that certain maintenance should be carried out on the play equipment including fencing etc. The Councillors' have asked for itemised estimate from Park Lane Playgrounds for each section that needs attention. The Chairman is still dealing with EIBE regarding warranty on the tower panels and roof. We are going to apply to Knabs Ridge Wind Farm for a grant and to check if our insurance would accept thermo plastic panels on the tower as these would last much longer.

Paul Trewhitt has kindly agreed to be our representative to check the playground equipment on a fortnightly basis and report back to the clerk. It was also suggested a sign should be placed in the play area asking anyone who notices any faults to report back immediately to the Parish Council

**Highways** – Our County Cllr Nathan Hull along with a colleague attended a meeting with our Chairman regarding the Pinch Point. It was suggested that the 20 mph sign should be extended from the school as far as Broomfield to help resolve the problems with speeding vehicles. Another suggestion was double yellow lines near the goit to stop unauthorised parking. The school had done some speed checks on Wreaks Road and they thought speed activated signs would be a good idea but would need Highways and Police approval. The Chairman met Amanda Barry HBC regarding the state of the land behind Broomfield which is overgrown and with large branches just dumped in the hedgerow, along with junk, bicycles, trolleys etc. and is in fact covering a drain preventing the dispersal of water which does not help the flooding situation.

**BIB** – proposed new shed at back of Broomfield – ongoing investigation BIB had apparently received the OK from a HBC council member Tom had forwarded this letter to another dept at HBC and is awaiting a reply.

**Bus Shelter** – On going nothing further to report at present

**Litter Bins** – The reply stated due to the limited number of replacement bins they were unable to add additional bins at this time.

Grass Cutting - The Councillors' decided a second cut should take place either late August or early September
