Damien Wilkinson Manager – from Kerrys attended the meeting and talked about the following issues: Some complaints had been received regarding noise levels at the mill he explained that they had stopped flour production since December due to H & S issues with that part of the mill other areas continued as normal. This meant that they had to bring in tankers containing flour due to the milling plant being out of action and this caused additional noise. He stated noise levels could increase until the matter was sorted. He invited anyone to visit the mill and he would give them a tour of their premises and an explanation of their working environment. Tankers from Whitworths and Clugson could deliver between 8 am to 8 pm any other large vehicles seen on Wreaks Road/Station Road were not delivering to the mill. A decibel test had been taken and was within the approved range. The financial situation regarding the major repairs are being dealt with by Global finance and once agreement has been reached work will go ahead and manufacturing will continue as before. Damien stated they had and are helping the local School with funds for their projects, Work to tidy up the grounds surrounding the mill/goit is on their agenda. Damien was thanked for attending the PC meeting

COUNTY COUNCILLOR'S REPORT - Nathan reported he had met Sarah Wood Practice Manager from the Doctors Surgery regarding parking issues. The private road at West House Gardens and the footpath outside the Surgery - Nathan is having difficulty in obtaining the relevant paper work which would state whether the developers were responsible for the work. He is meeting with Julian Smith our local MP shortly and he will discuss various issues including the recent two fatalities one in Burnt Yates and one on Skipton Road and also the pinch point, electric charging points for those who do not have private parking facilities and other Highway problems. Kex Gill should open in Spring 2026 this is NY biggest construction project. The area will be monitored closely this coming winter due to the heavy rainfall that we have experienced this year but NYH say contingency plans are in place. He also reported that 89.000 new homes in the district is the target over the next 20 years this equates to 4,500 per year

Updates on matters arising:

Playground: The Chairman stated we are awaiting quotes for fencing around the extended play area. He thanked Kerrys for allowing us the extra piece of land. Once we have all the relevant quotes for fencing and new equipment it will be discussed again with the Councillors. NYCC Annual Inspection will take place in October at a cost of £65 inc VAT

Highway updates: Complaints have been received about the car which parks on the footpath outside the shop in order to recharge its batteries. Nidderdale Way near goit nettles have grown and are almost covering the path - will be sorted. B Holmes to be asked to cut back a tree on Nidd Lane which is obstructing the street light. The TPO officer has looked at the state of a tree in the Vicarage garden and the Clerk to write to PCC regarding this matter. Grass Cutting: the majority has been cut but an area further down Nidd Lane needs to be added next year BIB: Trimming back bushes on the roundabout and cutting the saplings at the bottom of Lackon Bank still to be done because BIB have only just held a meeting to discuss this item. Apologies for jumping the gun Greenway Questionnaire Survey: This draft questionnaire was approved by the Councillors proposed by D Fisher seconded by R Houseman with one amendment to say that - This is only your views and will help communicate a collective view to NYC, the Greenway Extension steering group nd Sustrans. This survey does not mean that this extension is going to take place now or in the future

Change of banking: The PC now bank with Lloyds – However the Playground account will stay with Virgin Banking for the time being – all agreed

Christmas Tree Lights: The lights will be turned on for Advent and in January the lights will be taken off the tree and rehung. Further discussion will take place regarding the size of the tree in our January meeting
