MINUTES: It was proposed by R Houseman seconded by P Trewhitt and **RESOLVED** that the minutes of the meeting held on 24th October 2024 be confirmed as a correct record and were signed by the Chairman

COUNTY COUNCILLOR'S REPORT: Nathan reported he had met Julian Smith our MP regarding various Highway problems. Julian told him they had to prioritise accident black spot areas and told him the hill at Burnt Yates, Ripley to South Stainley, Menwith x roads and Dunkeswick Lane would be dealt with first. Once these areas had been dealt with the next most dangerous sections would be evaluated. Nathan stated speed cameras are a deterant and might be a good idea. He had received several complaints from residents in West House Gardens regarding the drains and sewerage on their estate. The paper work for Section 38 agreement appears to have been mislaid at NY but Nathan intends to hold a meeting with the residents and has asked them to bring their legal agreements with them in order for him to read through them on their behalf. Sara Wood the practice manager at the Doctors' Surgery is meeting with Nathan regarding parking on the road outside the surgery. One solution would be to turn the front lawn into a car park and another for the Surgery to place a sign asking patients to be a responsible neighbour and not park on the grass verge. 24 Bus will be increasing their charges to £3 but the Mayor is looking into whether anything can be done for them to remain at £2. The increase in National Insurance is going to effect many businesses in our region. More grants with become available but large cities will have a better chance of obtaining them. Lack of policing in our area was questioned by the Councillors but the police have very limited resources available to them. The traffic problems with the goit was raised again – this is an ongoing problem with NYH we will not give in until we find a solution

Updates:

The Play Area: Additional equipment and fencing for the playground has been left in abeyance for the time being. The clerk to check out the documentation relating to the Playground Inspection Report which took place on 10.10.24

Highway issues: The Chairman is in touch with AONB regarding the overgrown greenery on the Nidderdale Way path near the goit. The plastic bollards opposite the Doctor's Surgery have been damaged and could do with renewing. The Clerk had made enquiries as to whether Commuted Sums money could be used to purchase a seat at the Bus Stop on the corner of Nidd Lane. The Councillors will look into the feasibility of this and report back

BIB: Trimming bushes on the roundabout and the opposite side of road will be done in the near future

Greenway Questionnaire Survey: Leaflets in the shop, pub and doctor's surgery – please hand your completed forms into where ever you took one from. This is only a survey and will finish at the end of December but Paul asked as many people as possible to fill in the questionnaire so they would have a better idea of residents thoughts either for or against
