COUNTY COUNCILLOR'S REPORT: Nathan was pleased to report that the long awaited footpath outside the Doctors Surgery was to go in front of the Executive Council Committee for approval. The monieswill come from the Consolidated Active Travel Fund once approval has been granted. Regarding motorists parking on footpaths you can, if you wish, take photos of the vehicle along with the place, date and time and anonymously forward it to Harrogate Police and they can issue a fixed penalty. He stated the budget would give Councils less money and the Mansion Tax would affect quite a few properties in our area but this money would eventually have to be paid to the Government so would not help us locally
