- 4 COUNTY COUNCILLOR'S REPORT No report in his absence
- 5 **DISTRICT COUNCILLOR'S REPORT** Nathan Hull reported HBC Crescent Garden site was now in the process of exchanging contracts and it is proposed that the developer will provide 14 apartments, an art gallery, restaurant and 2 retail units. The new Council building should be ready for occupation by Autumn. With the sale of all the other Council properties it is envisaged it will only take half the allocated time to pay off the debt.
- PARISHIONERS' QUESTIONS Concerns were raised about the Certificate of Lawfulness for the retention of a dwelling to be occupied by persons not employed in agriculture. This means taking off the Agriculture License due to the fact that the owners have not been employed in agriculture for 12 years. Because this property has 12 acres of grassland attached strong feelings arose as to it's future use. The land has road frontage on to Station Road and major concerns are that this land could be sold to a developer for a housing project. The land is not part of the current application and therefore the PC are unable to make any comment.
