- 1 ELECTION OF CHAIRMAN It was proposed by R Houseman seconded by J Elvidge and RESOLVED that E March be elected as Chairman all were in favour
- 2 **DECLARATION OF ACCEPTANCE** E March duly accepted the position of Chairman and signed the declaration made before a Proper Officer of the Council of the Parish of Birstwith

- 4 ELECTION OF VICE CHAIRMAN It was proposed by D Britton and seconded by R Houseman and RESOLVED that M Worsnop be elected as Vice Chairman all were in favour
- MINUTES It was proposed by D Britton and seconded by R Houseman and RESOLVED that the minutes of the proceedings of the Ordinary Meeting held on 27th April 2017 be confirmed as a correct record and signed by the Chairman
- **APPROVAL OF ANNUAL GOVERNANCE STATEMENT** Proposed by M Worsnop seconded J Elvidge that the statement be accepted all were in favour
- 7 **DECLARATION OF INTEREST** M Worsnop declared an interest in item 14 on the agenda the Clerk's Salary
- 8 COUNTY COUNCILLOR'S REPORT Michael Harrison reported that he had been re-elected as our Conservative Councillor for the next 4 years. 3 delegates stood for election with no UKIP representative at this election. Michael informed us of his new role in Health & Adult Social Care which may mean he will not be able to attend as many Parish Council meetings but he assured us of his continued support. Trees along the roadside verge at Grange Farm have now been removed after a visit by CC Highways Dept who informed the new owner of the property the situation regarding these trees he will now plant them within the curtilage of his property.

- **ANNUAL ACCOUNTS** The annual accounts for the year ending 31st March 2017 were approved proposed by R Houseman seconded by J Elvidge all in favour
- 11 PARISHIONERS QUESTIONS None
- 12 UPDATES REGARDING:
 - a) Play Area: It was proposed by R Houseman seconded by J Elvidge that the insurance excess of £250 should be transferred from the Play Group a/c into the Parish Council a/c as this grant had been awarded from the windfarm re: repairs to Play Area entrance path in 2016. General maintenance OK still to fix large grab handle to slide and sandbags have been placed under part of roundabout to alleviate children trapping their feet. BHS requested the Play Area gates be opened for the annual show agreed.
 - b) Highway matters: to be reported to Area 6 Highways Grange Farm large bolders on grass verge outside property now covered with grass, opposite side of the road outside Grange Farm netting which covered a drain has lifted and is trip hazard copy to Michael Harrison. Utility trench on Darley Road very uneven and needs reinstating. Now the trees are in leaf on the brow of the hill on Darley Road pedestrians cannot see oncoming traffic. Saplings which have overgrown on the path on Darley Road need cutting back.
 - c) Broomfield Notice Board David Britton has kindly offered concrete flags to be placed in front of NB
 - **d) Grass Cutting** The Chairman and R Houseman will work out the actual area of grass that needs to be cut prior to quotes being obtained.
 - **e) Birstwith in Bloom** The BIB committee have organised members to cut certain grass verges in the village but the grass cuttings are been dumped in the hedge bottom. They are now looking to hire a

skip which could be placed inside the Show Field. The Chairman had also been informed that they plan to place water butts all over the village to enable watering of their planters. The Councillors' asked the clerk to contact BIB again regarding their Public Liability insurance cover. Although we have a copy of the BHS insurance certificate it was felt that written confirmation should be obtained stating that this policy will include any liabilities relating to all the BIB activities and they would also like ongoing inventories as and when items are added.

- f) Transparency Code Funding has now been received and will be used appropriately g) Telephone Kiosk re adoption of telephone kiosk on Elton Bank BT states that the Unitary Authority (Harrogate) objected to the removal of this kiosk in their recent consultation which means the kiosk will remain with a telephone service.
- **Internal Auditor** It was proposed by R Houseman seconded by J Elvidge that the auditor should be paid £25 for year ending 31st March 2017. As from next year the external audit will be carried out under our authority and the Chairman will liaise to see if the internal auditor would be willing to take on the full audit and what his fee would be.
