7 UPDATES REGARDING:

Play Area - The Chairman had a meeting with the Mill Manager, Mr Simon Bridge as to Parish Council concerns regarding the field gate and walls along Wreaks Road. The Chairman was informed this was of concern to him and in actual fact a contractor had already been appointed to do the necessary work. The mole situation seems to have resolved itself. The damage to the Play Area entrance and the Mill field caused by the flooding has now been reinstated. The Chairman and Parish Clerk are to look into signage for the play area regarding contacts, telephone numbers and addresses in case of emergencies

Highway Matters – D Holmes has agreed to cut trees back on Clint Bank in conjunction with NY Highways

Neighbourhood Watch -two people have expressed interest in this position Stone Bus Shelter – The clerk wrote to 3 local contractors asking if they would quote for painting the inside of the bus shelter and received only one reply. It was proposed by R Houseman seconded by M Worsnop that Nigel Martin's quote should be accepted all in favour

Nidderdale Strategic Partnership – Report from our Chairman who attended the meeting. The partnership suggested in light of the results highlighted during the recent Speed Watch exercise, the Parish Council should contact the Chief Constable regarding speeding through Birstwith and the possibility of speed cameras been employed. The 24 Bus Service operators Trans Dev are hoping to operate double decker buses once the Highways Dept have trimmed the over hanging trees along the route, thus elevating problems of buses being full by the time they get to Hampsthwaite. As from the 31st May the first Bus will leave Pateley Bridge at 6.50 am this will allow commuters to catch the 8am Leeds bus from Harrogate
