- 1 APOLOGIES: D Britton and R Houseman
- 2 DECLARATION OF INTEREST Carol Packer declared an interest in the Planning Applications for Dairy House and West House Farm Nidd Lane Birstwith
- 3 MINUTES It was proposed by M Worsnop and seconded by C Packer and **RESOLVED** that the minutes of the meeting held on 28th July and 18th August 2016 be confirmed as a correct record and signed by the Chairman
- 4 **COUNTY COUNCILLOR'S REPORT** Cllr Harrison said he had been misled about the roadworks on Clint Bank and he is still trying to find out when the reinstatement work will be carried out in front of Clint Hall Farm. Photographs of the area concerned had been passed on to NY Highways. He stated that the proposed re-routing of the A59 at Blubberhouses is still in the pipeline. Also the bypass plan for Killinghall will be resurrected and within a 2yr period the County will be required to put forward a fully costed bid before any further action will take place. The Government have pledged 20 million for superfast broadband which will mean 96% of households will benefit from this faster service. Allerton Park waste disposal site is on budget and will open in 2018. Grange Farm HBC Legal Dept have lodged a dispute on the highway problem
- 5 **DISTRICT COUNCILLOR'S REPORT** District Councillor Nathan Hull told the meeting that HBC have not stopped displaying Planning Notices. The Parish Councillors' thought that some notices had not been put in strategic places and therefore local residents in some cases had no idea a planning application had been applied for.

6 UPDATES:

(a) The Play Area - due to have it's annual inspection shortly

(**b** & **c**) **Highway Matters:** Lackon Bank has been marked by the Highways Dept prior to repair. Photos of the nettles and overgrown greenery which are restricting the use of the footpath on Darley Road have been forwarded to Highways Dept. The clerk to write to David Holmes and Martin Wood thanking them for cutting back saplings etc on Clint Bank and Darley Road. Saplings opposite the shop need cutting down and R Houseman has agreed to collect and dispose of greenery. The Christmas tree lights need to be taken down and rehung before bad weather sets in.

(d) Neighbourhood Watch - John Reed has now officially retired from this duty. The new system has still not been finalized by the main Neighbourhood Watch committee

(e) Telephone Kiosk Station Road – The councillors' were asked to think about replacing the old glass panels with new ones etched with historic local information which could be sponsored by local organisations and possibly would be eligible for a grant

(e) Bus Shelter – Interior painting now finished. Clerk to write to David Bird to thank him for donating the paint
