## 7 UPDATES REGARDING:

**Play Area:** Play Area inspection report found several minor low risk faults but these have now been rectified. The mill field wall/fence has now been repaired and a new gate post installed this is thanks to Kerry Ingredients

**Highway matters:** Nigel Smith is the new NY Highway Area 6 manager. Skeltons need to be contacted as Elton Bank needs cutting. The footpath along Darley Road which is over grown along with the excess water during wet periods on Hampsthwaite Lane is being looked into by NY. The drain outside School House is still under discussion with the Maintenance Manager and Highways Officer. He has been requested to inspect the drain to ascertain whether the main drain is a Highway drain and not a Yorkshire Water sewer. The Chairman to contact the Police regarding vehicles parked on the bend outside Collin Bank which cause problems to vehicles travelling in both directions.

Piece of land to the rear of Collin Bank which was rented from HBC by the late Dorothy Barker enquiries to be made as to it's ownership now her property has been sold

**Telephone Kiosk Station Road** – It was unanimously agreed that notices be placed in the notice boards and church magazine to see if anyone is interested in sponsoring a glass panel on which significant dates and info regarding the village heritage could be printed.

**HBC** – Displaying of public notices relating to Planning Applications – HBC have been told that these signs must be displayed in prominent positions and on public highways and not on private roads

**Christmas Tree opposite the shop** – The Chairman and D Britton undertook the task of taking the lights off the tree – one section needed replacing and a further 5 lengths will be purchased as the present number of lights are now inadequate due to the size of the tree.
