At present the councillors in our area have about 2400 electorate some more some less so moving some borders will have to happen.

7 UPDATES REGARDING:

Play Area: Reg Houseman stated the grass/weeds around the play area still needed to be cut but will be done shortly. John Elvidge had received HBC written report on the Play Ground inspection. He stated that he would deal with the few areas that needed attention but the report on the whole stated that everything was 'low risk'. The clerk reported the new bank account was in the process of being set up with Yorkshire Bank

Highway matters: Still no reply from the police regarding parking problems on Birstwith Grange and Collin Bank. Collin Bank – Highways have patched part of the road. The Ginnel barrier – entrance to Collin Spring Court will be replaced by Highways. Local resident fell due to raised curbs on footpath near Collin Bank reported to Highways they will make repairs but due to financial restraints no date given

Birstwith Church FC – Lackon Bank footpath. It was agreed by the Councillors' at the last PCC meeting that a small donation could be made available towards this project. The clerk was asked to write to County Cllr Michael Harrison to see if any monies could be made available from the Community Initiative fund and he has reported back that he *might* be able to contribute something – awaiting reply

- 8 BHS e-mail should we as a village work towards becoming 'Birstwith in Bloom' as it is the shows 150th Anniversary. The Councillors' discussed this matter and requested that the BHS submit a plan to the Parish Council of particular areas they had in mind. If for instance the car park wall were to be included permission would have to be obtained from HBC as the car park is owned by them.
- 9 NALC Transparency Fund for Smaller Authorities The Parish Council can make an application to cover the costs of setting up their website and purchasing computer equipment etc as their turnover is under £25,000 per annum. The Chairman and Clerk were asked to look into this matter and report back to the next meeting
