1 **Apologies:** None

- **Parishioners' questions:** The visitor was concerned about a sign which had been placed in close proximity to his boundary detailing a public footpath right of way. The PC regretted they cannot take further action as it is on private land.

- 6 COUNTY COUNCILLOR'S REPORT County Cllr Harrison reported that adult social care was putting extra strain on there already tight budget. A lot of Councils propose to lobby government to increase the current social care budget. Pot holes were discussed at length once again and even though previously he reported extra capital had been made available for rural roads and lower classified roads on the whole the problem had not improved. He stated in part this was due to the harsh winter. He stressed that anyone can report a problem by going on to North Yorkshire gov website and pin pointing the actual area.

8 UPDATES REGARDING:

Play Area: The damper on the gate is still causing problems and will be looked at again. **Highway matters:** Pinch system Wreaks Road – according to Area 6 Highways a stop sign cannot be used here. If motorists are already ignoring a GIVE WAY sign it's is unlikely to be any better with a STOP sign. Water costantly running from one side of road to another on Hampsthwaite Lane – some drainage investigations have been carried out however utility works may have damaged the highway gully system. A Highway engineer is looking into this and further action based on the outcome will then take place. Damaged school barriers -Highways have placed an order for the replacement they have to be made specially due the gate mechanism. Parking on pavements on Station Road and Collin Bank – regrettably still no nearer solving the problems. Drainage problem back of Broomfield under investigation. **Grass Cutting** – Still working on areas to be cut prior to getting quotations Grit Bins - Birstwith Grange and The Allotments - Highway Officer has completed a grit bin assessment and these areas do not meet the criteria for Authority funded grit bins. The PC are looking into possibly purchasing grit bins for these areas Birstwith in Bloom – The PC representative attended the last BIB meeting and reported that BIB are now separately funded although still under the umbrella of BHS. They have applied for some grants but have had no response to date. The PC thought they were keeping the village neat and tidy. The PC need to ascertain in writing that the BHS public liability insurance still stands now that they are funded separately.
