- 2 PARISHIONERS' QUESTIONS None
- 3 **DECLARATION OF INTEREST** J Elvidge declared an interest felling of Sycamore Tree 2 Station Plantation and M Worsnop declared an interest in Clerk's Salary
- 4 MINUTES It was proposed by E March and seconded by J Elvidge and RESOLVED that the minutes of the meeting held on 26th July be confirmed as a correct record and signed by the Chairman
- 5 COUNTY COUNCILLOR'S REPORT Cllr Harrison reported that the Parish survey on Vehicle Activated Speed signs or Speed Indicator Devices had been approved in principle. Accordingly the relevant Portfolio Executive Member and the Corporate Director of Business and Environmental Services Directorate has been tasked with producing an amended policy to allow parishes to purchase and maintain VAS subject to County Council oversight.
 Kex Gill has had semi permanent repairs but will be closed shortly for one week in order to complete the work. However this is only an interim measure and a new road will eventually be built.
- 6 **DISTRICT COUNCILLOR'S REPORT** District Councillor Tom Watson informed the meeting that an Inspector for the Local Plan had been appointed his name is Richard Schofield. Once Mr Schofield understands the key issues in our area a second inspector may be appointed. This will apparently help with the capacity issues at the Inspectorate. The Planning and Development team have been going through a service review and the new name is Place-shaping and Economic Growth Service. This name better reflects the range of corporate priorities and projects that the service is delivering

7 UPDATES:

- (a) The Play Area New clamper has been fitted to the gate. Awaiting annual inspection report
- **(b) Highway Matters:** Subsidence on car parking area at back of 15 Collin Spring Court After official inspection it was reported that the problem was not due to tree roots but caused by the contractors huts and equipment. Home Housing are liaising with the contractors involved and will report back. Repairs to highway outside Broomfield by Yorkshire Water now completed but the Councillors' thought the problems had probably been caused by the HGV's going to the mill. The road was not originally built to carry these very heavy vehicles and repairs have needed to be carried out 4 times in the last 2 years. Broken down car has been removed from village car park. The telephone kiosk at Collin Bank is in need of repair and painting quotes to be obtained for the work. Grass cutting Skeltons to be asked to cut Elton Bank and the Chairman agreed to look at other verges which need cutting prior winter and get a quote from W Benson
- **(c) Birstwith in Bloom** The Chairman to chase up once again the written confirmation re: public liability insurance cover, street furniture licence and the Butterfly notice board in the playground.
- **(d) Clerks salary:** It was proposed by E March seconded by J Elvidge that the clerks salary should be raised by inflation as an interim measure and backdated to April this year
