- PARISHIONERS' QUESTIONS Cllr Fisher told us he had received a complaint from a resident re the state of Darley Road close to Greenwood House and on Nidd Lane the grass verge around the Jubilee tree needed cutting. Further enquires as the PC thought that BIB were undertaking maintaining this area.
- **3 DECLARATION OF INTEREST** None
- 4 MINUTES It was proposed by R Houseman and seconded by D Fisher and RESOLVED that the minutes of the meeting held on 25<sup>th</sup> July be confirmed as a correct record and signed by the Chairman
- 5 COUNTY COUNCILLOR'S REPORT E mail report in his absence. Kex Gill see under correspondence. County Council finances the Government annoucement earlier this month on funding was very positive for the County Council. A number of funding streams that were due to run out this year were renewed. That said, it was still only a 1 year funding settlement so the long term financial picture is still uncertain. It also assumes the council continues to levy the 2% social care precept.
- **DISTRICT COUNCILLOR'S REPORT** District Councillor Tom Watson informed the meeting that HBC had only collected 97.8% in Council tax during 2018/19. 1127 had been employed in 2018/2019 with a personnel turnover of 16.1%. Waste and Recycling is now under control but in a minority of areas there are still a few problems. Tom would like any residents to contact him on 01423 780840 if problems arise with this service. Dacre Surgery closure around 96% of households in the area have been targeted with a leaflet regarding this service which includes a sheet for residents comments

#### 7 UPDATES:

- (a) The Play Area Restraint on outer gate looking into the possibility of rehanging gate the other way. Climbing frame new brackets now in place and have solved the problem. Annual Inspection Report only minor problems reported. Shackles to swings and basket to be renewed in 6/12 months time. Path from road to playground gate in need of some work which the PC are looking into to find the best medium to use. It was quoted on Facebook that someone had tried to set fire to the picnic table but after a thorough inspection no damage was found.
- **(b) Highway Matters:** The road repair work outside Broomfield has now be resurfaced. The Bus Stop on Darley Road we have now received a grant from NYCC to put a hardstanding at this bus stop the work to commence shortly.
- **(c) Birstwith in Bloom -** Congratulations on being awarded a Gold Award Very well done **P**C to look into a possible donation to help further their work if the PC receive a detailed project
- **d) Telephone Kiosk** painting of the inside of the kiosk Nigel Martin felt the wrong sealant had been used by the glaziers, but the Chairman will make further enquiries
- e) Grass Cutting: Has now taken place
- f) School Clock: -Now been repaired
- g) CIL Community Infrastructure Levy Charging Schedule has been submitted to the Secretary of State for Housing, Communities and Local Government for Examination, along with supporting documents. The time table for the examination is in the hands of the Planning Inspectorate, there is significant amount of work to be undertaken for the implementation of CIL. It is hoped that planning applications determined in mid 2020 should be subject to CIL charges
- h) Land behind Collin Bank Our District Councillor Tom Watson is looking into this on our behalf. However the PC wrote to HBC regarding this subject in January 2018 but as yet had not received a reply
